Position:

TCI Foundation invites applications for the position of Lab. Technician purely on contractual basis. The selected candidate on this position would be required to maintain good liaison with authorities and officials of NVBDCP, State VBDCP, District VBDCP, internal and external agencies for the progression and completion of program activities within the given timeframe.

Purpose:

To support activities in Laboratory/field diagnosis of Malaria for effective implementation of GFATM supported Intensified Malaria Elimination Project (IMEP-2) in various States at Regional levels The positions are meant for different Malaria endemic states.

To strengthen the program technically and epidemiologically at RoHFW levels, which invariably impacts the efforts of NCVBDC to eliminate malaria within stipulated timeframe.

Job Responsibilities:

- 1. To perform diagnosis of malaria through blood slide examination and/or rapid diagnostic kits
- 2. To undertake field visits as and when required
- 3. To analyse the data of diagnosis by age, gender, locality etc
- **4.** To undertake part in imparting training to trainees
- **5.** To undertake any other task assigned by the Reporting authority.

Deliverables: The Lab. Technician will be required to submit a Monthly Activity Report and Annual Report to Reporting Officer with a copy to NCVBDC. Performance appraisal would include review of monthly activity reports, field visits, timely completion of activities and innovations done and annual assessment.

Selection: Selection and appointment shall be carried out through advertisement followed by walk-in-written test/interview, if shortlisted.

Service Tenure: The candidate would be required to serve the organization till 31st March 2024 provided there is no termination of services by the organization.
